Annual Report of the Session 2023-24

To prepare the annual report of the Academic Session of 2023-24, the Academic Coordinators & Committee Coordinators conducted a meeting with the undersigned and drafted the following report of the Annual Activities during the Session 2023-24:

- 1. Result Analysis of the Final Semester Examination:
 - a) Total 220 students appeared in the LL.B. Three Year Program, out of which 201 students have been declared passed in the said examination. Twenty-nine students passed with First Division, and the total passing percentage for this session was 91.36%."
 - b) Sixty-eight students appeared in the B.A.LL.B. Five Year Program, out of which 65 students have been declared passed in the final semester examination. Three students were passed with First Division, and the passing percentage was 95.59% in the final semester examination.
- 2. World Environment Day was celebrated on 5th June, 2023 at the Campus and the plantation drive conducted in the vicinity.
- 3. MoUs have been signed with numerous colleges, universities, and NGOs spread across the country to promote knowledge exchange and other socio-legal activities.
- 4. The NAAC Peer Team visited the college on 14th & 15th September, 2023 and the college has been awarded with B+ Grade.
- Two-Days National Workshop has been organized in the campus on 09th & 10th
 September, 2023 by the Commission for Scientific and Technical Terminology, Mnistry of Education, Govt. of India, New Delhi.
- An Orientation Program was organized on November 6th and 7th, 2023, for the new batch. Mr. Prashant Singh Atal, Member of the U.P. State Legal Council, and Mr. Rakesh Mishra, S.P.O. of D.G. Telecom, were invited as the Chief Guest and Guest respectively.
- 7. Students from both programs participated in the Road Safety Program organized at the college, district, and university levels. They were actively engaged in speech, poster/art, and quiz competitions, ultimately achieved awards in few categories.

- 8. The Women Development Committee of the college conducted an awareness drive in the near by college and the village of Galahamau, which has been adopted by the college, to promote legal literacy and other development programs in the village. The committee endeavored to address the grievances of females and others by guiding them on the appropriate approach to reach the concerned authorities for assistance, with the support of the Legal Aid Cell of the college.
- 9. The Legal Aid Cell conducted Bar Visits, Court Visits, Jail Visits, and an Internship Program with permission from the competent authority, and the students actively participated in each activity.
- 10. As per the part of the curriculum, the assignement topics have been allotted to the students in the month of December, 2023.
- 11. The sports week organized by the sports committee from 09th December to 15th December, 2023 to promote the physical activities.
- 12. The students advertised the benefits and importance of the National Legal Services Authority in the vicinity and organized a successful event for National Voters Day on 25th January 2023. They performed a "Nukkad Natak" in different Gram Sabhas under the umbrella of the Cultural Committee and Legal Aid Clinic.
- 13. The Republic Day was celebrated on 26th January 2023, and students presented speeches, plays, and other programs on this special day to recall the history and struggle of independence and honor those who sacrificed their lives to make the country independent.
- 14. An Alumni Meet and Result Distribution Ceremony were organized on 15th December, 2023. The Alumni Association donated Rs. 1,20,000/- (One Lakh Twenty Thousand) to the Alumni Fund for student welfare.
- 15. Due to the Delayed session of the University, few curricular and extra-curricular activities could not be completed as per the plan.
- 16. After the announcement of the General Election of the Member of Parliament in 2024, a Voter Awareness Drive was conducted by the college on a large scale to educate voters about the importance of voting in order to establish a strong government for the nation.
- 17. A National Seminar was jointly organized by TRC Law College and Vidya Bharti Uchcha Shiksha Sansthan on the campus on 12th and 13th April 2024, blending both

Academicians from both national and international institutions participated in the event. More than 100 Research Papers have been presented in the Seminar.

18. The 3rd T.R.C. National Moot Court Competition was organized from April 25th to 27th, 2024, at the college. Eighteen teams participated from across the nation, including Symbiosis Law College Pune, Lloyd Law College, U.P.S. Dehradun, Government Law College Mumbai, BBAU (Central University), BBD University, Ram Śwaroop University, etc. The Final Round Competition was judged by Śri Rajeev Maheshrawam, ADJ Barabanki, Smt. Sandhya Srivastava, Chairman Waqf Tribunal Lucknow, Sri Rakesh Mishra, SPO, Sri Vineet Singh, Advocate High Court, Lucknow Bench and Sri Chandra Shekhar Pandey, Joint Director, Prosecution Lucknow zone. The University of Lucknow and BBD University contested in the final round, and BBD University emerged as the winner. They were awarded with cash prize and a trophy.
