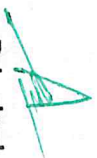

There was more than 72% of students pass successfully in B.A.LL.B.I semester, 80% in B.A.LL.B.III semester, 79% in B.A.LL.B.V and approx. 76% in B.A.LL.B.VII semester. Further in the LL.B. programme, there were 82% students passed in LL.B. I semester and 83% students passed in LL.B. III semester internal test.

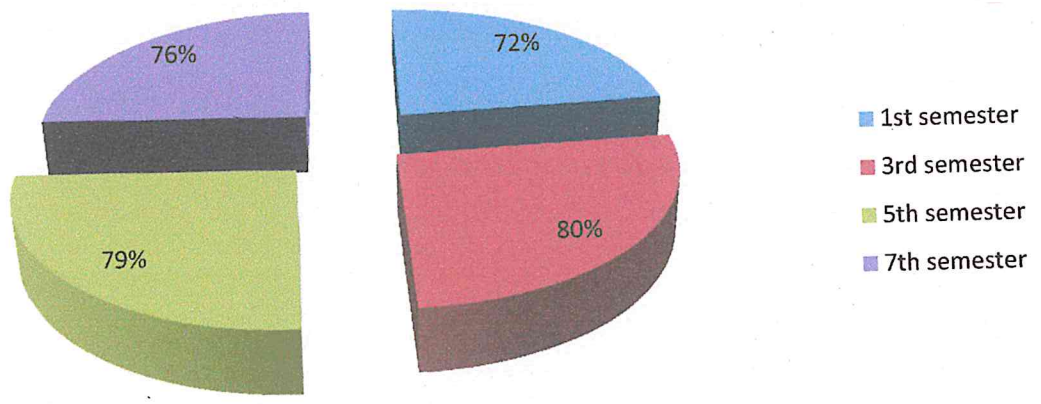

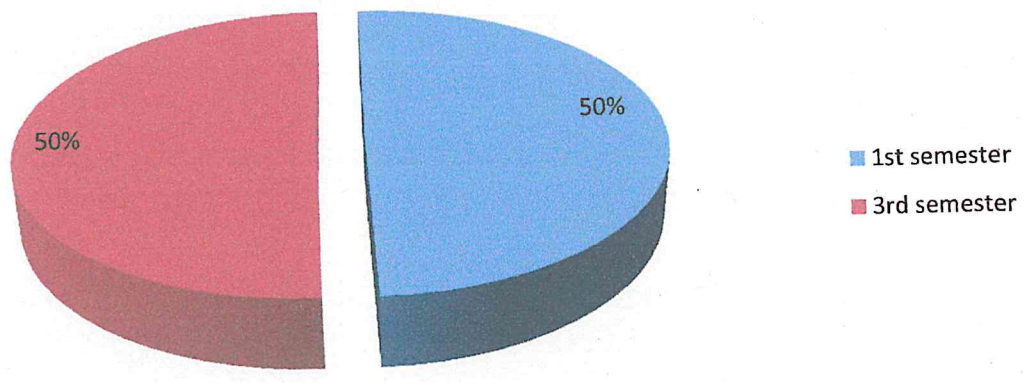
