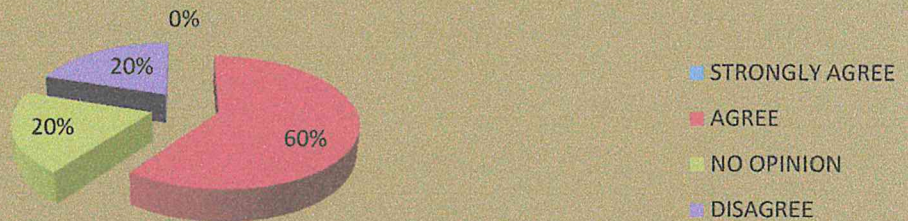

Action Taken Report on Judges/Senior council's Feedback


