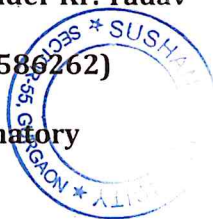

## **Purpose of the MoU**

### **3. Internships and Practical Training:**

- Providing internship opportunities for law students to work with the NGO on animal cruelty cases.
- Offering students hands-on experience in legal proceedings and advocacy against animal cruelty.

### **4. Legal Aid Services:**

- Establishing a legal aid cell in collaboration with the NGO to address animal cruelty issues.
  - Assisting in filing legal cases, petitions, and other formal proceedings for animal welfare.

## **Roles and Responsibilities**

### **The College:**

- Nominate faculty members and students to participate in the activities under this MoU.
- Provide necessary infrastructure, such as seminar halls or research facilities, for collaborative activities.
- Incorporate animal welfare topics into its curriculum and encourage student participation.

### **The NGO:**

- Offer expertise, case studies, and legal cases for student involvement.
  - Provide training to students and faculty members on animal rights and laws.
  - Collaborate with the College to publish joint reports, research papers, and legal recommendations.

### **Duration and Termination**

1. This MoU shall remain in force for a period of 5 years from the date of signing unless terminated earlier by either Party with a prior written notice of 15 days.
