Anti-Ragging & Student Grievance Redressal Committee Meeting Minutes






Anti-Ragging & Student Grievance Redressal Committee Meeting Minutes

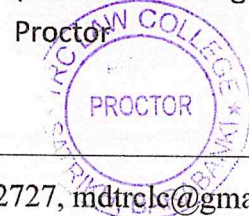
The meeting of the Anti-Ragging & Student Grievance Redressal Committee was held on 11th July 2023 at 03:00 P.M. in the Board Room to discuss the roles and responsibilities of the committee members and to ensure the campus remains a ragging-free zone. Mr. Veer Vikram Singh addressed the committee members, emphasized that it is the responsibility of each member to closely monitor the activities of senior students. He also instructed the committee to conduct a meeting with the first-year students in the seminar hall to inform them that if any senior student attempts to harass junior students, the affected student should immediately inform to the member of the committee (AR&SGRC) to report the complaint. The committee members were asked to disseminate contact numbers to the students so they can reach out in case of any emergency. The activities of ragging will not be tolerated, and strict action will be taken against those involved. The Proctor instructed the female members of the committee, Mrs. Deepmala Srivastava and Mrs. Rohini Tripathi, to stay in continuous contact with female students to prevent ragging both inside and outside the campus. While no cases of ragging have been reported on campus so far, it is important to remain vigilant and active at all times. The committee members assured the Proctor that they would ensure this. Regarding the grievances, the committee members informed that no grievances had been received so far. The Proctor instructed the members to ensure that any grievance received would be immediately addressed and resolved with due proceedings. The meeting concluded with a brief discussion and instructions to the members to ensure the proper placement of Anti-Ragging posters and stickers around the campus to raise awareness among students about the consequences of ragging.
