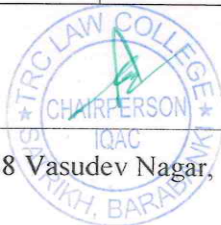

Agenda 1: Review of minutes of 9th IQAC Meeting and subsequent action taken

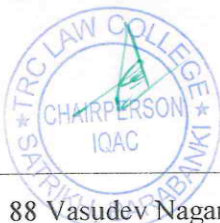

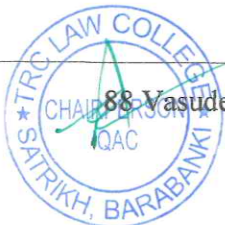
