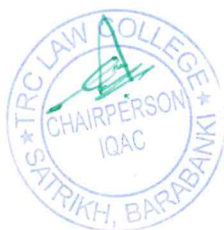
Agenda 6: To discuss on upcoming curricular and co-curricular activities according to academic calendar.

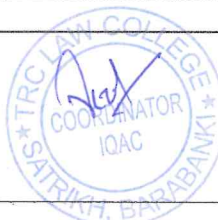
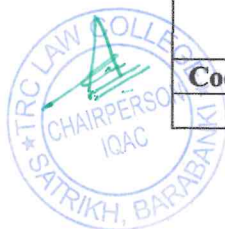

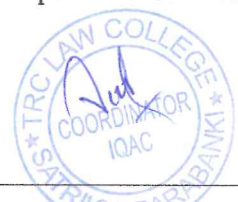
Agenda 3: To discuss the status of Admission in both the programmes & Commencement of Classes.

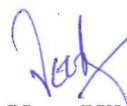

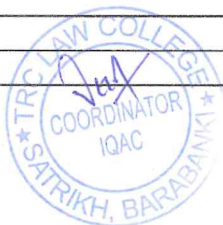
