## Governing Body: Minutes of the Meeting

The Meeting of the Governing Body held on 18<sup>th</sup> May, 2025 i.e. Sunday at Board Room, T R C Law College, started from 10:00 AM, The Principal Dr. Ashwani Kumar Gupta welcomed all the members and with the assent of the Chairman, Governing Body, the discussions were made accordingly on the following Agendas:

**Agenda No.1 Review and discussion of the minutes of the previous meeting held on February 2, 2025.**

### **Resolution:**

The Principal provided information regarding the meetings of the Academic Council and the Board of Studies, which were conducted on March 9, 2025, and April 13, 2025, respectively. During these meetings, the Academic Council approved the Code of Conduct for all stakeholders, the Examination System and its regulations, Admission rules, Teaching Rules and Regulations, as well as the ordinances for the LL.B. (3-Year), B.A.LL.B. (5-Year), LL.M. (1-Year), LL.M. (2-Year), and four (04) Diploma Programs. Following this, the Board of Studies approved the syllabus for all these programs. The members then reviewed the minutes of those meetings and provided directives for further implementation as required.

**Agenda No.2 Proceedings required from the parent university following the approval of all programs by the Academic Council and Board of Studies.**

### **Resolution:**

The Committee Member directed the Principal to communicate all proceedings of the Academic Council and the Board of Studies to the Parent University, particularly regarding the approval of syllabi for all programs and other academic activities. This notification is essential to formally inform the Parent University about the commencement of both existing and newly introduced programs from the upcoming academic session (2025-26), in alignment with the college's autonomous status.

## Agenda No.3 Discussion on all programs fees finalized by the Finance Committee.

### Resolution:

The members of the Governing Body reviewed the minutes of the Finance Committee and formally consented to the fees as determined by the Finance Committee.

## Agenda No.4 Fulfillment of mandatory approvals and proceedings from the parent University i.e. Dr. Ram Manohar Lohia Avadh University, Ayodhya for the Commencement of the Ph.D. in Law program, including necessary steps for the nomination of research supervisors.

### Resolution:

The Principal presented the Ph.D. in Law Ordinance to the Chairman and members, informing them that it is prepared in accordance with the guidelines of the University Grants Commission (UGC). Prof. (Dr.) Anand Vishwakarma, a nominated member from the Parent University, and Prof. B.P. Singh recommended obtaining approval from the Academic Council and adopting all measures and regulations prescribed by the UGC. Following the Academic Council's approval, an official intimation, along with a copy of the Ph.D. in Law Ordinance, must be sent to the Vice-Chancellor of the Parent University for formal approval. Additionally, an intimation regarding the commencement of the LL.M. (One-Year) and LL.M. (Two-Year) programs from the 2025-26 academic session onwards must be sent to the Parent University along with the required supporting documents.

Regarding the nomination of research supervisors, the nominee from the Parent University directed that a panel be constituted to finalize the names of research supervisors. This panel should promote existing faculty members who meet the educational qualifications prescribed by the UGC and subsequently confirm the appointment of research supervisors accordingly.
