The Principal, Dr. Ashwani Kumar Gupta, extended a warm welcome to all members. With the consent of the Chairman of the Governing Body, discussions were carried out on the following agendas.

Agenda No.1 Review and confirmation of the minutes from the previous meeting held on May 18, 2025.

Resolution: The Chairman and Members of the Governing Body reviewed the minutes of the meeting held on May 18, 2025. They inquired about the recommendations made during that meeting, and the Principal confirmed that the proceedings had been carried out in accordance with the directions of the committee. After due consideration, the Governing Body approved and confirmed the minutes.

Agenda No.2 Approval for reduction in seats of the LL.M. One-Year Program and revision of syllabus for both LL.M. One-Year and Two-Year Programs.

Resolution: During the meeting, a detailed discussion was held with the Principal regarding the LL.M.

One-Year Program. The Principal explained the reasons for reducing the intake, and after thorough deliberation, the committee unanimously decided to reduce the seats by **fifty percent (50%) i.e. 30**

Seats in the LL.M.- One-Year program from the Session 2026-27 onwards. Furthermore, the syllabus

revision of both LL.M. programs was taken up. The Principal presented the proposed layout of the

revised syllabus for both programs, and after reviewing the proposal, the committee suggested

corrections in Title and Content of the proposed syllabus and directed the Principal to implement these

corrections and place these revisions before the **Board of Studies** and the **Academic Council** for their

recommendations and approval. It was emphasized that the revisions must be carried out strictly in

line with the guidelines and recommendations of the concerned statutory bodies.

Agenda No.3 Consideration of freeship provided to students of all programs in the 2025 batch.

Resolution: The Principal shared a detailed overview of the students who had been granted freeships for the Academic Session 2025–26. These details were presented program-wise, showing how the College Finance Committee had considered and approved the requests made by students who require financial assistance. The committee acknowledged the Finance Committee's efforts and appreciated the initiative as a meaningful step toward helping students continue their education without financial barriers. The Total Freeship Rs. 297460.00 granted inclusive of all Programs.

Agenda No.4 Formation and approval of various committees in line with UGC guidelines.

Resolution: On the discussion of this agenda, the principal informed the committee that in accordance with para 12.2 of The Gazette of India, CG-DL-E-05042023-244940, EXTRAORDINARY, Part-III, Section-4, No.222, UGC Notification dated 03 April 2023, certain committees are required to be constituted. While some committees are already functioning as per the statutory guidelines, the **Planning & Evaluation Committee** is yet to be formed, and the **Admission Committee** for the Academic Session 2026–27 requires constitution and approval.

The Principal also introduced the **Examination Committee**, which has already been constituted. After discussion, the Principal recommended names for the respective committees, and the committee members consented to these recommendations. It was agreed that all committees will function strictly in accordance with the guidelines provided by the statutory bodies.

Agenda No.5 Discussion on infrastructure and other amenities required.

Resolution: In the meeting, the Principal highlighted the need for establishing a separate **Research Room** and an **Auditorium** to strengthen the institution's infrastructure. The Governing Body carefully considered this proposal, and the Chairman directed the **Finance Committee** to prepare a comprehensive budget covering these requirements. It was further instructed that the proposed budget be presented in the upcoming Finance Committee meeting for detailed consideration and approval, ensuring that the infrastructural development is planned and executed in a structured and transparent manner.

Agenda No.6 Discussion over the previous and proposed annual budget.

Resolution: In the meeting, the previous annual budget was presented before the committee. The members, along with the Chairman, reviewed the previous budget and directed the Finance Committee to make tentative annual budget for next session and add any additional requirements into the proposed budget and prepare it accordingly. The Principal informed the committee that, up to 20.02.2026, the total expenditure amounted to ₹5,83,434 on the Library, ₹90,000 on Workshops and Seminars, and ₹2,20,000 on Student and Staff Welfare. After reviewing these figures, the committee emphasized that the Finance Committee is empowered to prepare, execute, and maintain the budget along with proper records of accounts. The Committee empowered to the Chairman, Governing Body to review and approve the proposed budget as per the recommendation of Finance Committee.



