- Appreciating the sacrifices made by freedom fighters, and developing an awareness of the significance of non-violent resistance strategies employed by Mahatma Gandhi and other leaders.
- Essentially, fostering a deep understanding of the complex process of India's liberation struggle and its lasting impact on the nation's identity and political landscape.
