Paper Code: BL-0705

Course Description: Uttar Pradesh Revenue Code,2006 is a code applicable in Uttar Pradesh dealing with the matters related to land revenue, tenures, reforms, etc. This Act consists of 16 chapters, 234 Sections and 4 Schedules. It minimizes the procedural complications prevailing in old laws. It has repealed the Uttar Pradesh Zamindari Abolition and Land Reform Act 1950, UP Land Revenue Act, 1901 and other 37 enactments which had become obsolete and were too complicated to adhere to comply as a whole. This new Code provides a fine balance between the conservation of natural heritages and the demand of land for developmental activities. This Act was assented by President of India on 29th of November, 2012 as Act No. 8 of 2012.
